Institution implements accredited Bachelor and Master, as well as One Level Medical Educational programs in:

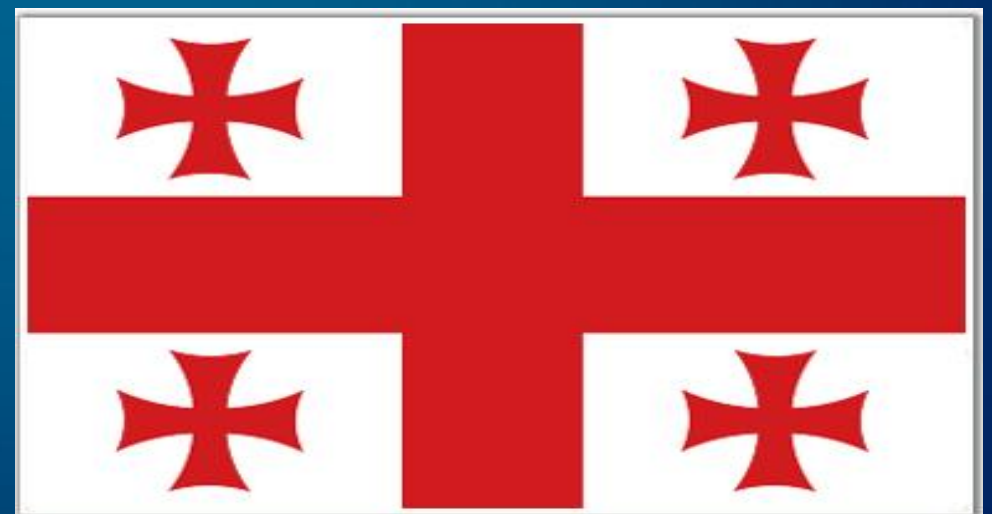

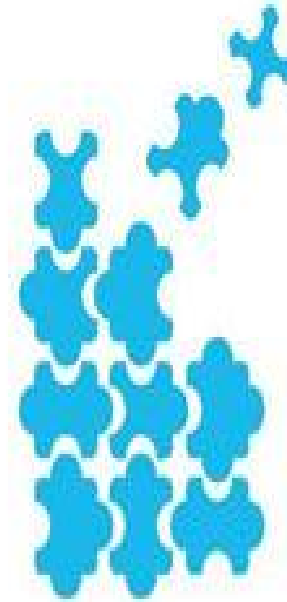

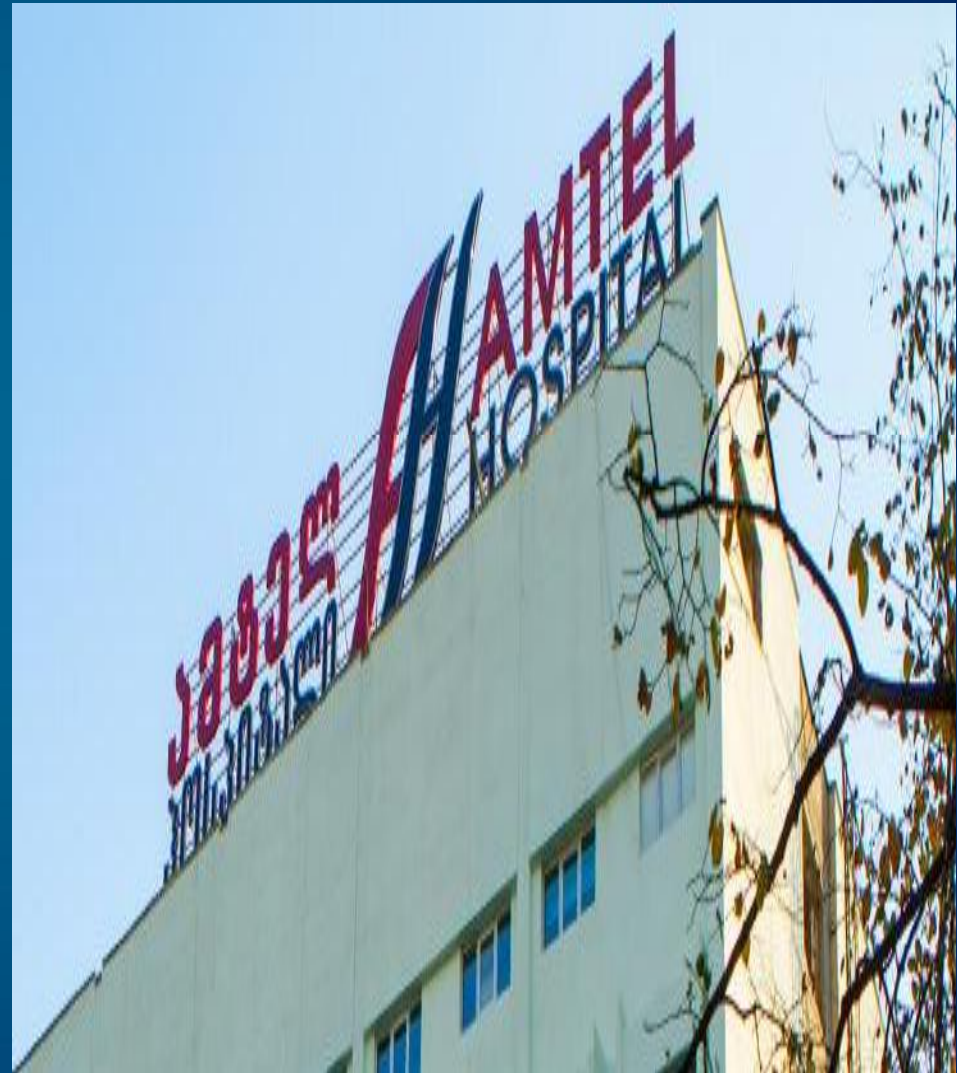
